- \*If any information on page two is not known at this time, I understand that an amended trial application must be submitted no later than 3 months prior to the first trial date.
- \* I understand that the classes, limits and the closing date cannot be changed, if less than 3 months prior to the first trial date, or if the premium has been approved and published – whichever date comes first.
- \*I understand that a premium must be submitted to CPE no later than 3 months prior to the first day of the trial. I understand that a premium cannot be published until CPE approves our premium draft (the premium must be emailed to CPE in WORD – version 98 or later, or in a pdf format), and the premium draft cannot be reviewed until any amended trial application information has been received by CPE. I understand that premiums are usually reviewed within a week of receipt by email at the CPE office.
