

## NOTICE TO EXHIBITORS

\* The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

\* Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee.

\* It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and / or children. Any exhibitor whose dog(s) and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.

\* No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

\* Exhibitors are responsible for complete, accurate, and legible information on the entry forms: illegible or incomplete entries cannot be entered in the show.

\* **Email:** Correspondence via email is required; check that you've provided a valid address. If it has changed, **please** contact CPE before sending your entry, so that it's changed in the national database. Also, please set your spam filter to allow the trial secretary's email address or you may not receive your confirmation.

### Directions

**THERE WILL BE NO MEASURING OF DOGS AFTER JUDGE'S BRIEFING BEGINS EACH DAY - ALL DOGS WITHOUT A PERMANENT CARD MUST BE MEASURED BEFORE THE JUDGES BRIEFING TO SHOW THAT DAY - THERE WILL BE NO EXCEPTIONS**

**PRIZES & AWARDS:** Placement rosettes or ribbons will be awarded for 1<sup>st</sup> through 4<sup>th</sup> place for Qualifying and non-qualifying scores for all classes. Dogs with an NT (no time) are not eligible for any ribbons. Qualifying ribbons will be awarded to all dogs receiving a qualifying score, and Jr Handlers in Standard.

**EXERCISE YOUR DOG RESPONSIBLY! PLEASE PICK UP AFTER YOUR DOG AT THE SHOW SITE AND HOTELS! ALL DOGS MUST BE ON LEASH EXCEPT WHEN IN THE RING OR WARM UP AREA. THERE IS A LEASH LAW IN THE TRIAL SITE'S STATE.**

Assuming indoor crating is allowed, there is ample space. If COVID precautions are still required, it is possible that exhibitors will be asked to crate from their cars.

**Warm-Up Area:**  
A regulation bar jump will be available near the ring.

**Food:**  
There will be no food provided at this trial.

## ENTRY FEES

Rates are based on the total number of runs for dogs from the same household. Entries must be mailed together.

1-10 runs: \$14 each

**Jump Heights** – no dog will jump lower than 4”

P-Card = Permanent Card: the lowest allowable Regular height a dog may jump in CPE.

General CPE rules for entries/show site:

- Dogs must be at least 15 months or older the first day of the trial
- Blind (both eyes), lame, in season or aggressive dogs may not enter the show. The Club may choose to exclude any of the above from the site.
- Dogs must be registered with CPE prior to the closing date of the trial, or by the trial date for Day of Show entries. Registration forms are on the Forms page: [www.k9cpe.com](http://www.k9cpe.com). Forms MUST be mailed to CPE and are processed 2-3 times per week. CPE ID numbers are emailed to legible email addresses. Registrations can only be processed from mailed forms.
- Dogs must be able to be measured at their first show. If a dog cannot be measured, the dog cannot run and no refund will be issued. Dogs within ½” of a jump height require at least one more measurement. When dogs reach their second birthday, a measurement is required. All dogs must be measured at their first trial regardless of jump height.
- Only CPE Judges can measure dogs.
- Electronic shock collars are not allowed at ANY CPE trial – training or bark.
- Handlers in all classes are permitted to walk the course, without a dog, prior to the start of the class. A warm-up jump shall be provided for all entered dogs. No relieving of dogs in the warm-up area.

### **Dogs in the ring, leashes, exiting the ring**

- Dogs shall run without anything attached to its body. This is for the safety of the dog. This includes no: collars, stitches, wraps or any other item. The only exception is a small barrette or rubber band to keep hair out of a dog’s eyes.
- Leashes may not have anything (other than name/license tags) attached to them when used in the ring.
- Dogs may enter the ring on a collar, quick release harness or head halti/leader. If prong collars are allowed per the show site, they may *not* be used to take a dog into the ring.

- Handlers may not carry their leash with them on the course – if done so, an NT will result. Exception: Handicapped handlers that have a mobility problem in picking up the leash at the finish may put their leash in their pocket – the leash must be out of sight.
- Dogs must be under the handler’s control when leaving the ring or the judge may enter the run as No Time - NT.

### **Training a dog in the ring during a run**

We (FKPS) will offer Declared training in the ring. The handler has the option if they want to use a toy or training aid at any time during their run, the handler must approach the Judge during Walkthrough or previously in that trial day for the Judge to approve the toy or training aid for use on the course.

- Handler must alert the Judge upon entry to the ring that the dog will be TIR. Handler is then allowed to have a reasonably sized silent toy/aid with them for use once their run has started (this toy must be approved by the Judge of record PRIOR to the start of the class to determine its eligibility, absolutely no food/scents/audible devices). The toy is NOT allowed to be used in either gate chute or prior to the previous dog leaving the ring.

See the online rulebook or current member letter for additional rules.

The following items *are* considered training in the ring (see Fix and Go):

- Violating the 4-paw safety rule (directing the dog back onto the contact)
- Start line stay – leaving the dog and going back again to reposition the dog after the handler passes the plane of the first obstacle (before the handler leaves the dog, repositioning or repeated commands can be a delay of start)
- Putting the dog back on the table in the point games

### **While running on course**

- The handler will direct the dog through the course without a collar or lead.
- Food, toys, training devices (includes fanny packs and leash attachments) are not allowed within 10’ feet of the ring. Clickers, training whistles and squeaky toys are not to be used within distraction distance of the ring.
- The handler may not carry anything that could aid the dog in its performance. Exclusion: Handicapped/Differently Abled Handlers using a cane, scooter, wheelchair, etc., to enable their progression around the course.

The handler may use any verbal or visual commands to direct the dog through the course. The Judge may assess a 5-fault penalty to elimination for any command that is not given in a sportsmanlike manner. Faults can be, but are not limited to: foul or abusive language, display of anger, extreme frustration or excessive harshness. If the fault is severe enough, the Judge has the right to excuse the exhibitor from the ring and / or the remainder of the trial. If excused from the trial, a report would be filed with CPE. See Faults, Eliminations and Excusals in the rulebook.

## FKPS K-9 Training Agility Trials

Agility trials are an important part of the agility community. Exhibitors enjoy the camaraderie, hanging with friends, practicing new skills and earning titles. As we know, due to the Covid-19 virus and the pandemic, we have had to change many things in our daily lives. The same is true for agility. At FKPS K-9 Training we have been planning, evaluating, and researching ways to safely hold agility trials. We will be complying with the Minnesota Governor's guidelines for opening up the state and for entertainment events. If trials cannot be held, we will notify all competitors by email before the closing and all checks received will be shredded. We want exhibitors, workers and judges to be in a safe environment. As a result, we will be changing our trial format and we will be imposing new guidelines and restrictions. This set of restrictions will be in effect for the July 2-4, 2021 trial. For agility trials offered by FKPS K-9 Training at this time, the following guidelines will be in effect.

1. The entry limit has changed to a limit of 375 runs.
2. Walk throughs will be limited to 10 handlers.
3. Anyone entering the building will need to wear a mask which will include all exhibitors, workers, judge, and ring crew. Individuals do not need to wear a mask when they are outdoors however strict six-foot distance must be observed if at all possible unless masked.
4. Exhibitors will maintain six-foot social distancing inside and outside the building. Please be respectful of your fellow exhibitors.
5. There will be no seating/viewing area and no chairs will be allowed in the building.
6. A gate steward will be at the door directing you as to when to enter the building for walk-thru and running your dog. Gate steward will check your dog in.
7. Only 10 or less exhibitors will be allowed in the building while they are in queue for their runs.
8. A leash runner will use a grabber to pick up and transport the leash. Grabber will be sanitized after each grab. If permitted by the organization on the date of the show the leash may be put in your pocket or wrapped around your neck for your run.
9. Ribbons will not be self-serve. Please see a committee member when getting ready to end your day and let them know the tally of how many of each ribbon you need. They will be brought to you.
10. No food will be available onsite. There are many restaurants that have delivery and can bring your food to the parking lot. In addition, there are many close restaurants you can drive to.

11. There will not be results books onsite. After each class results will be emailed out electronically to everyone. You can check your email or electronic device for results. There will be a copy posted on the wall you can take pictures of as well. No stickers will be printed.
12. Course maps will be posted outside the building. There will not be any paper course maps so plan on taking a picture of the maps.
13. Please do not bring CATCH cakes or desserts to share with exhibitors. No food can be distributed at this show.
14. Please wash your hands frequently. There will be hand sanitizer available at all entrances and exits. Please use them or wash your hands each time you go in and out of the building.
15. In the event you are ill, you are required to stay home. You will receive a FULL refund if you are in any way feeling ill at this trial.
16. If you do not wish to comply with all of the rules stated in this document you will receive a full refund and your entry is withdrawn. Covid-19 continues to change our daily lives. If you are entering this trial, be sure you are comfortable with our new guideline and are willing to comply with social distancing and wearing a mask. Exhibitors not complying with these guidelines will be excused from the trial. Please print and sign this document along with the Waiver and Liability document for CPE and return to Sue Kvale right away at 9510 400th Street, Cannon Falls, MN. 55009. You will not be allowed to run at this trial unless I have these on file.
