**NOTICE TO EXHIBITORS**

- \* The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport.
- \* Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee.
- \* It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and / or children. Any exhibitor whose dog(s) and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- \* No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- \* Exhibitors are responsible for complete, accurate, and legible information on the entry forms: illegible or incomplete entries cannot be entered in the show.

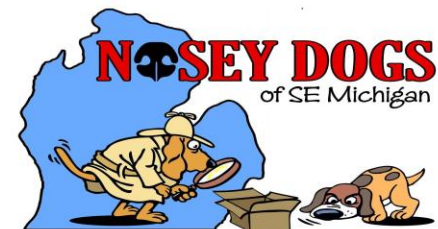

**DIRECTIONS TO THE TRIAL SITE**

This trail is to held at Stony Creek Orchard, approx. 4 ½ miles west of the “bypass” on the east side of Romeo, on 32 Mile Rd. (Sometimes called St. Clair in Romeo.) For most exhibitors, the use of Van Dyke (M-53) from either the north or south is recommended. The orchard is not far from Rochester Rd., and exhibitors coming from Lapeer, Oxford, Rochester, etc. can take Rochester Rd. to 32 mile (Romeo Rd.) Stony Creek Orchard is 2.3 miles east of Rochester Road.
