- \* The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- \* Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee.
- \* It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and / or children. Any exhibitor whose dog(s) and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- \* No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- \* Exhibitors are responsible for complete, accurate, and legible information on the entry forms: illegible or incomplete entries cannot be entered in the show.

### **DIRECTIONS:**

**From the South:** Take I-65 North to Fern Valley Road (KY-1747). Go approx. 3.6 miles, then turn left onto Shepherdsville Rd (2052). Go another 1.9 miles and our building will be on the left.  
**From the North:** From I-65 South, take exit 131A Watterson Expressway (I-264 E). Take Newburg Rd on exit 115 South take exit 131 A Watterson Expressway (I264 E). Take Newburg Rd on exit 115 (KY-1703 S). Turn left on Indian Trail then turn right onto Shepherdsville Rd. Our facility is on your right.
