

## NOTICE TO EXHIBITORS

- Dogs must be at least 6 months of age on the day of the trial entered.
- The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and their dogs are familiar with the odors.
- Entry fees will not be refunded if a dog is absent, disqualified, excused, or barred from competition by action of the show committee.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- Exhibitors are responsible for complete, accurate, and legible information on the entry forms; illegible or incomplete entries cannot be entered in the show.
- No prong collars; and no electronic or training collar devices (this includes shock & bark collars) are allowed on the grounds of a CPE trial.
- Lunch is NOT available for purchase at the trial site.

ANISE (Pimpinella Anisum) – Used in Level 2 through Level C

CLOVE (Eugenia caryophyllata) – Used in Level 3 through Level C

CYPRESS Cupressus sempervirens) – Used in Level 5 through Level C

VETIVER (Vetiveria zizanioides) – Used in Level C

Placements will be awarded for first through fourth place. Placements will be determined by no faults first, then by least amount of time. If there is a tie of score and time, each dog will be awarded the same placement, with the following placement(s) not awarded, if any. Placements are not awarded if the dog has a non-qualifying score. Rosettes will be awarded for Level Titles. A Special Rosette will be awarded to new Champions (Level 5) and new Extraordinaire Titles (Level C)

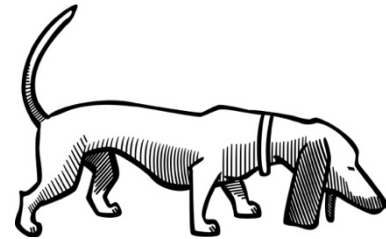
