

NOTICE TO EXHIBITORS

- * The safety of the dogs and people is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
 - * Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee.
 - * It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and / or children. Any exhibitor whose dog(s) and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
 - * Exhibitors are responsible for complete, accurate, and legible information on the entry forms: illegible or incomplete entries cannot be entered in the show.
 - * While walking on show grounds, all dogs must be kept on a leash no longer than 6 feet in length. Dogs should be kept a reasonable distance (8-10 feet) apart. A Scent Sport trial is not an activity where dogs should socialize. Longer lines or flexi leashes may be used during search, but when not searching need to be reduced to a length of no more than six feet. Handlers will be given time to change leashes, if needed, before their search.
 - * Dogs that are environmentally sensitive and need additional space should wear a red bandana to indicate this. The bandana can be worn around the dog's neck, or attached to the leash or harness, but should be prominently displayed and secure. The bandana may not hinder the dog during search.
- *ALL CRATING WILL BE IN OUTSIDE. ALL PEOPLE AND DOGS MUST REMAIN AT LEAST 6 FEET FROM EACH OTHER.**

FROM THE SOUTH: Take I-196 N/US-31 N to exit 34 for M-89 towards Fennville. Turn right onto M-89 E. Go 3.1 miles and turn left onto 62nd St. Go 1 mile and turn right onto 126th Ave. Go 0.2 miles to trial location on left.
