

COVID GUIDELINES FOLLOWED AND WAIVERS NEEDED

NOTICE TO EXHIBITORS

- * The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport.
- * Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee.
- * It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and / or children. Any exhibitor whose dog(s) and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- * No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- * Exhibitors are responsible for complete, accurate, and legible information on the entry forms: illegible or incomplete entries cannot be entered in the show.

DIRECTIONS TO THE TRIAL SITE

Wolverine Dog Training Club, 20782 Orchard Lake Road 48336; From the west: Take M14/I-96 past I-275 to Merriman Road exit. Turn left (north) on Merriman Rd. and continue 4 miles to just past 8 Mile Rd. Turn right into second driveway. (Note: Merriman Rd. changes its name to Orchard Lake Rd. north of 8 Mile.) From the south take I-275 to 8 Mile Rd. exit. Turn right on 8 Mile and go about 4 miles to Orchard Lake Rd. Turn left on Orchard Lake Rd., then turn right into the second driveway. From north or east: take I-696 to the Orchard Lake Rd. exit. Then turn south on Orchard Lake Rd. At Grand River, turn left, then right to continue on Orchard Lake Rd. Continue south on Orchard Lake almost to 8 Mile Rd. Wolverine is the second to last driveway on the left.
