

## NOTICE TO EXHIBITORS

- \* The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- \* Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee.
- \* It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and / or children. Any exhibitor whose dog(s) and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- \* No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- \* Exhibitors are responsible for complete, accurate, and legible information on the entry forms: illegible or incomplete entries cannot be entered in the show.

**DIRECTIONS** to Bachman's Cedar Acres Nursery (23004 Cedar Avenue, Farmington, MN 55024):

- Take Exit 81 off Hwy 35/35W to Co Rd 70/210th St West in Lakeville. Stay on this road when it turns into 215<sup>th</sup> Street West.
- Approximately 4 miles after exiting Hwy 35, 215<sup>th</sup> comes to a "T" at a stoplight on Cedar Avenue (you can no longer go straight on 215<sup>th</sup>).
- At that "T", take a right onto Cedar Avenue.
- Destination is on your left after about 1.5 miles.
- Look for the large purple & white Bachman's signs and the South sign (on the left) just before the retail parking lot.
- Take the left at the South Paws sign (service road), and then a right at the next South Paws sign. Exhibitors should park in the back greenhouse (employee) parking lot, not the retail parking lot.
