

## NOTICE TO EXHIBITORS

- \*Dogs must be 6 months of age on the day of the trial.
- \* The safety of the dogs and people is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- \* Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the show committee.
- \* It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and / or children. Any exhibitor whose dog(s) and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- \*No Entry Fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act or an public enemy, or any other cause beyond the control of the organizing committee.
- \* Exhibitors are responsible for complete, accurate, and legible information on the entry forms: illegible or incomplete entries cannot be entered in the show.
- \*No prong collars; and no electronic or training collar devices (this includes shock & bark collars) are allowed on the grounds of a CPE trial.
