

### NOTICE TO EXHIBITORS

- Dogs must be at least 6 months of age on the day of the trial.
- The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and their dogs are familiar with the odors.
- Entry fees will not be refunded after the closing date or in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- Exhibitors are responsible for complete, accurate, and legible information on the entry forms; illegible or incomplete entries cannot be entered in the show.
- No prong collars; and no electronic or training collar devices (this includes shock & bark collars) are allowed on the grounds of a CPE trial.
- **No Lunch** is available for purchase at the trial site.

Limits: 150 runs per judge per day

There will be a warm-up area containing boxes with the odors to be used. Exhibitors are not allowed to bring their own odors or practice boxes. To do so will result in being excused from the trial.

### **NO DAY OF SHOW ENTRIES**

CONTAINER & INTERIOR CLASSES WILL BE HELD INDOORS. VEHICLE CLASSES ARE SCHEDULED FOR OUTDOORS AND MAY REQUIRE WALKING ON UNEVEN SURFACES. IN CASE OF INCLEMENT WEATHER VEHICLE CLASSES MAY BE INDOORS. EXTERIOR CLASSES WILL BE HELD OUTDOORS AND MAY REQUIRE WALKING ON UNEVEN SURFACES.

Same day move-ups will be allowed between Rounds 1 & 2; and move-ups will be allowed for the next day.

The club will be following CPE & Nebraska COVID-19 guidelines. Specific information will be sent with the judging program. Limited crating may be available inside the GLOC building or you may crate in your car.

CPE requires a COVID-19 waiver which you will be required to sign. It will be included with the judging program.

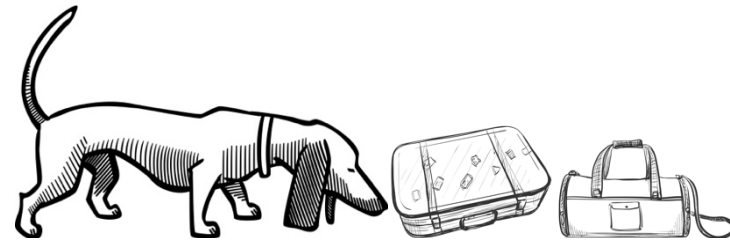
