

NOTICE TO EXHIBITORS

- * The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- * Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee.
- * It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and / or children. Any exhibitor whose dog(s) and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- * No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- * Exhibitors are responsible for complete, accurate, and legible information on the entry forms: illegible or incomplete entries cannot be entered in the show.

DIRECTIONS:

From the North: From Ocala (I-75 South) Take Exit 301 (US-98 N/Cortez/SR-50 & go West (4.2 mi). Turn Left onto Spring Lake Hwy/CR-541 (3.6mi). Turn Right onto Hayman Rd/CR-576 (0.8mi, flashing light) 25592 Hayman Rd on the Left.

From the South: From Tampa (I-75 North). I-75 North to Exit 293, CR-41N. Turn Right onto Blanton Rd/CR-41N. Continue to follow CR-41N (0.1mi) CR-41N becomes Spring Lake Hsy/CR-541 (2.5 mi). Turn Left onto Hayman Rd/CR-576 (0.8 mi, flashing light). 25592 Hayman Rd on the left.

From the East: From the Turnpike upon reaching 1-75 follow the directions above from the North.

From the West: From the Suncoast Pkwy exit County Line Rd & Turn East. Proceed to Broad St/US-41N (1.4 mi). Turn Right onto Ayers Rd (5 mi). Ayers Rd becomes Hayman Rd (4.4 mi). 25592 Hayman Rd is on your Right
