

### NOTICE TO EXHIBITORS

\* The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

\* Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee.

\* It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and / or children. Any exhibitor whose dog(s) and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.

\* No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

\* Exhibitors are responsible for complete, accurate, and legible information on the entry forms: illegible or incomplete entries cannot be entered in the show.

At the very next intersection, turn right and proceed to traffic light. Turn left at light onto E. PATRICK ST. Follow to small industrial park (S & S Tire) on your left, just past McDonalds. Turn left into the industrial park and continue to the last building on the left. **From the east:** Take I70 WEST to Exit 56. Continue on BOWMANS FARM RD. Continue on E. PATRICK ST. to small industrial park just past McDonalds on your left. **From the west:** Take I70 East toward Frederick to exit 55, SOUTH ST. Follow directions above, "from the south"

**CPE general SpeedWay trial rules: see the online rulebook at [www.k9cpe.com](http://www.k9cpe.com) for further info on divisions and complete details.**

**General CPE rules for entries/show site:**

- Dogs must be at least 12 months or older the first day of the trial
- Blind (both eyes), lame, in season or aggressive dogs may not enter the show. The Club may choose to exclude any of the above from the site.
- Dogs must be registered with CPE prior to the closing date of the trial, or by the trial date for Day of Show entries.
- Electronic shock collars are not allowed at ANY CPE trial – training or bark.
- Handlers in all classes are permitted to walk the course, without a dog, prior to the start of the class.
- No relieving of dogs in the warm-up area.

**Dogs in the ring, leashes, exiting the ring**

- Handlers have a choice regarding dogs wearing collars. Dogs may run courses with or without one collar. Collars should preferably be quick release style, and may be flat buckle, rolled leather, or flea prevention. No attachments of any kind are allowed on the collar.
- Dogs shall run without anything attached to its body. This includes no: stitches, wraps or any other item. The only exception is a small barrette or rubber band to keep hair out of a dog's eyes.
- Leashes may not have anything (other than name/license tags) attached to them when used in the ring.
- Dogs may enter the ring on a collar, quick release harness or head halti/leader. No prong collars are allowed per the show site.
- Handlers may carry their leash with them on the course – if done so, the leash must be in a pocket, out of sight of the dog.
- Dogs must be under the handler's control when leaving the ring
- **Food, toys, training devices (includes fanny packs and leash attachments) are not allowed within 10' feet of the ring. Clickers, training whistles and squeaky toys are not to be used within distraction distance of the ring.**
- The handler may not carry anything that could aid the dog in its performance. Exclusion: Handicapped/Differently Abled Handlers using a cane, scooter, wheelchair, etc., to enable their progression around the course.
- The handler may use any verbal or visual commands to direct the dog through the course.
