\* The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

\* Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee.

\* It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and / or children. Any exhibitor whose dog(s) and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.

\* No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

\* Exhibitors are responsible for complete, accurate, and legible information on the entry forms: illegible or incomplete entries cannot be entered in the show.

#### DIRECTIONS:

From Cleveland: I480 SE to rt 14 SE for 43.9 miles. To Washingtonville, Oh 44490. Turn rt onto Painters Path (next to Huntington bank building. The building is now a dry goods store, South on Painters Path for 1,600 feet.

From Akron: I76 E to rt 14 SE. then follow above directions.

From the South: RT 7 N. to Rt 11 N. (25.2 miles) to rt 46. at exit ramp turn rt onto rt 46 (2.3 miles). At first traffic light turn right on rt 14 west (4.1 miles). Turn left onto Painters Path at Huntington bank in Washingtonville OH 44490. Travel 1,600 feet to building site.

From I 80 Western Pa: I 80 west into Oh Take rt 11 south to SR46. Then follow directions from the south.

No more than 6 entries are allowed per envelope.

Only exception – all dogs within one envelope have the same 5 digit CPE member ID number.

Entry Method – First Received: No opening date. Entries may be mailed/received at any time once the premium has been published  
Overnight envelopes must have the recipient's signature waiver signed or the envelope may be refused or delayed

Final Closing Date: December 8, 2021

No Refund of Pre-Entries withdrawn after the closing date

Checks will be cashed on closing date.

Trial limit is 400 runs per day.

A dog may only enter 6 runs per day per CPE SpeedWay rules.

A handler may enter as many runs as they wish.

**CPE general SpeedWay trial rules: see the online rulebook at [www.k9cpe.com](http://www.k9cpe.com) for further info on divisions and complete details.**

**General CPE rules for entries/show site:**

- Dogs must be at least 12 months or older the first day of the trial
- Blind (both eyes), lame, in season or aggressive dogs may not enter the show. The Club may choose to exclude any of the above from the site.
- Dogs must be registered with CPE prior to the closing date of the trial, or by the trial date for Day Of Show entries.
- Electronic shock collars are not allowed at ANY CPE trial – training or bark.
- Handlers in all classes are permitted to walk the course, without a dog, prior to the start of the class.
- No relieving of dogs in the warm-up area.

**Dogs in the ring, leashes, exiting the ring**

- Dogs may run with or without a collar. If dog is wearing a collar it needs to be a flat buckle collar with nothing hanging from it.
- Leashes may not have anything (other than name/license tags) attached to them when used in the ring.
- Dogs may enter the ring on a collar, quick release harness or head halti/leader. If prong collars are allowed per the show site, they may *not* be used to take a dog into the ring.
- Handlers may carry their leash with them on the course – if done so, the leash must be in a pocket, out of sight of the dog.
- Dogs must be under the handler's control when leaving the ring
- Food, toys, training devices (includes fanny packs and leash attachments) are not allowed within 10' feet of the ring. Clickers, training whistles and squeaky toys are not to be used within distraction distance of the ring.
- The handler may not carry anything that could aid the dog in its performance. Exclusion: Handicapped/Differently Abled Handlers using a cane, scooter, wheelchair, etc., to enable their progression around the course.
- The handler may use any verbal or visual commands to direct the dog through the course.
